Stefura Dance Studios is authorized that in the event of an injury and an inability to reach the parents, to seek emergency medical assistance for the dancer.

FEES & PAYMENTS: Fees per year (September 16/10 – May 8, 2011) (See Terms and Conditions on reverse).

Registration fee is \$25 per family, non-refundable. Tuition Fees do not include HST. Minimum number of classes per year is 32. Fitness Tax Credit provided for all dancers 16 and under.

TERMS and CONDITIONS

- 1) **Period of Instruction:** The course shall consist of weekly dance instruction to be held at Stefura Dance Studios, 145 Evans Avenue, at the hours as determined by the Artistic Director in the published Class Schedule for 2010/2011.
- 2) **Duration of Course:** The course of dance instruction will commence the September 16, 2010 and finish with the Annual Concert to be held May 8, 2011 at Living Arts Centre. There will be no classes during Thanksgiving, Christmas, March Break and Easter. Other cancellations are at the discretion of the Artistic Director. Stefura Dance Studios will endeavor to hold all classes as are reasonably possible including the make-up of canceled classes.
- 3) **Trial Period:** For all new and returning dancers to Stefura Dance Studios, there is one free trial class and a full refund is available during this time, less the registration fee of \$25.
- 4) **Cancellation, Withdrawal, and Refunds:** Those dancers who withdraw prior to commencement of classes are entitled to a full refund, less the \$25 non-refundable registration fee. Once the dancer has been enrolled in the course of instruction, no refund will be given under this contract and the full tuition amount will be due and owing to Stefura Dance Studios. In the event that the dancer becomes unable to continue with the course of instruction because of severe injury or prolonged illness, Stefura Dance Studios in its sole discretion may consider a cancellation of the contract and may refund a portion of the fees. Any such requests for refunds shall be accompanied by a signed doctor's report, written on the doctor's letterhead, stating the nature and extent of the injury or illness which prevents the dancer from continuing with the course of instruction. Refunds, or credits, if any, will be at the discretion of the Artistic Director.
- 5) **Referral Discount of \$50.** For every new student that an old student refers, each is eligible for a \$50 discount. This discount will apply until the end of October 2010 only. The full name of the student must be provided on the contract in order to receive the \$50 discount/rebate.
- 6) **Class Attire (Hair and Dress Code):** The dancer and parent agree to abide by the class "dress code" as outlined at the beginning of the 2010-2011 dance season. The dancer may not be allowed to take class if not dressed properly.
- 7) **Attendance:** If the dancer is going to be absent, a minimum 48 hour notice should be given to Stefura Dance Studios via telephone or email message. In the event of sudden illness or incident leading to absence, a message should still be left with Stefura Dance Studios. Giving no notice is considered an unexcused absence. When a dancer accumulates three (3) unexcused absences, Stefura Dance Studios reserves the right to disallow the dancer to perform in any concerts and reserves the right to remove the dancer from the choreography and, if deemed necessary, removed from Stefura Dance Studios completely, without refund. Dismissal based on accumulated unexcused absences will first be dealt with via a probation notice from Stefura Dance Studios to the student and parent. If any classes are missed within three (3) weeks of a performance, be it an excused or unexcused absence, Stefura Dance Studios in its sole discretion reserves the right to disallow the dancer to perform.
- 8) **Disciplinary Action:** Should the dancer not be considered suitable for classes due to a disciplinary problem, or should a parent display inappropriate behavior, the dancer may be expelled from Stefura Dance Studios by the Artistic Director. The discipline of the classes and the consideration and determination of any expulsion shall be at the sole discretion of the Artistic Director. Expulsion is without consideration of refund.
- 9) **COSTUMES**
Jazz, Ballet & Modern Costume Deposit: A costume deposit of \$75 is required at the time of registration for the purchase of the dance costume for the year end show and any other performances, photo day, etc. A balance may be due upon completion of the costume, depending on the final cost of the costume. The costume then becomes property of the dancer.
- 10) **Returned Cheques & Overdue payment:** It is agreed that in the event that any cheques made payable to Stefura Dance Studios are returned by the Bank for any reason, the parent agrees to pay Stefura Dance Studios a \$20.00 service charge for handling the cheque so returned and that the funds owing to Stefura Dance Studios shall become payable immediately. Any payment that is overdue shall be subject to 2% interest per month.
- 11) **Timing of Registration and Payment of Fees:** I understand that no classes can be taken unless a completed registration contract is received and payment received in full. (with the exception of students taking one free trial class - see section 3). Any payment that is overdue shall be subject to 2% interest per month.
- 12) **Use of Image:** For promotional purposes I agree that if my dancer's photo is chosen, I allow my dancer(s)' image to appear in promotional material (printed and/or website).
